- The September 3, 2021 meeting that you called for at 4pm with very little notice to anybody. At that meeting Al Fusco was made the Code Enforcement Officer and she would like clarification because it didn't say what his hours were going to be, what his salary was going to be. Is he certified as a building inspector? Are you going to be using Ms. Ovenseen and Mr. Fusco and if Mr. Fusco is doing this for the village how many different jobs does he have? He works with other municipalities, she doesn't know how he fits it all in on his schedule, he must be a magician.

- O Al Fusco replied that the Village Board and himself are working out the logistics of what they are going to do to help the building inspector on various projects. He is not a magician but he is a very smart guy. He is a certified code enforcement officer, he has a staff of 30 people, 9 of which are certified code enforcement officers. His office is very capable of handling everything we need to in the Village of South Blooming Grove.
- Kristie Johnson was there a resolution that listed hours and salary for Mr. Fusco? If you are still
 working out logistics and details why did they rush to appointment as these things should be listed in
 a resolution for the public to know and to remain transparent.
- Sue Anne Vogelsberg The Friday special meeting was not noticed. It stated that Engineer Fusco would be the Code Enforcement Officer. Who do we submit incident reports to? Do we submit them to the building inspector, Ms. Ovenseen or to Mr. Fusco. Again, how is Mr. Fusco going to be paid and she just heard you are going to hire another clerk, she doesn't know where you will be getting the money for this as the current budget doesn't have a line item for that position.
- 18 Emily installed fencing that straddles a municipal common drainage easement and because the fence is there now the water flow is obstructed. She submitted an incident report on September 4, 2021 Code 235-17 states easement cannot be obstructed by fencing and the fence goes right through it.
- Any updates on Government chain of command during a village emergency that takes place from Sundown Friday to Sundown Saturday. There needs to be something in place and it cannot be a phone number.
- o 185 Prospect continues to operate as an Air BNB, another incident report has been submitted. What is the point of having a code if not enforced.
- O Community Day updates? We need to use robocalls to keep the community informed. When the hurricane came it was after the fact that we got notification and when I emailed the Mayor she advised there is not routine maintenance on the roads and the culvert drains on prospect are clogged so there was no place for the water to go and if maintained maybe there would not have been such an issue with the road. Communication is important.
- O She was disappointed in the village's 9/11 ceremony on Sunday, what was held on Saturday was respectful and honored all the lives of all people lost but on Sunday where were the citizen, there were no families, she felt it was embarrassing and disrespectful.
- O Attorney Ugell responded regarding the progress of the prosecution of 185 Prospect and he has been in contact with Jeanne Ovenseen over the last few weeks, he has seen Sue Ann Vogelsberg incident reports and emails. The building inspector filed papers last week and we are waiting for a court date. There was some delay at the Town Court system. Should be on the calendar in the next few weeks to further prosecute this building owner.
- o **Trustee Feldman** replied regarding the hurricane and stated we are really lucky and he saw the mayor in the early morning on Pennsylvania and at a tree down on Dallas and Duelk. Thank you.
- o **Joel Stern** all incident reports should be sent to village hall.
- Naomi Fingerhut On Peddler Hill and at 185-187 Prospect Road people are leaving garbage cans
 out at the end of their driveway almost in the road and are filled for almost the entire week, instead
 of putting out right before pick-up. It is creating a dangerous situation especially when driving at
 night.
