When you reduce the budget for trucked in water it seems irresponsible. There is conflict of information between the County, the Department of Health and the Village. Where is the money coming from? Will employees contribute to that because there is a fiduciary responsibility.

- O Jodie She doesn't believe three minutes is enough time to comment, she is going to go line by line and ask questions. The board advised that she could submit comments in writing. Independent Accounting, she is wondering why? Who pays Kraushaar salary? She doesn't see DPW in the budget at all, \$750,000 budget that was approved. Bus operations jumps out in a big way, she did her own calculations and the projected year \$240,00 and the budget next year states \$247,500 for a grand total over 3 years of one million 1,640,157. However, the revenue only adds up to \$116,000. This doesn't include salary, three minutes is not enough. These buses are not serving all of the community causing a deficiet.

Subject: Public Hearing 2025 Tentative Budget

The heart of New York Home Rule is for the people to govern without the legislature impeding on its elected government and its affairs. The dark side of New York Home Rule is that it can easily be manipulated to create tyranny or as we have here in South Blooming Grove, a Theocracy imposing itself on a Democratic Republic to extinguish the fundamental rights of the public given by the US Constitution.

The village has slowly implemented a policy that chills the public's political speech and its right to consume another speaker's political speech in the marketplace of ideas. Today's 2025 Budget Hearing is a prime example.

On September 19th, 2024, the Village Planning Board implemented a new hearing rule requiring the public to sign-in with name and address as a condition of speech. Then on September 24th, 2024, during the Village Regular Board Meeting, Joel Stern called for the complete removal of the public comment period due to me not providing my name and address, which is my first amendment right, McIntyre v Ohio Election Commission, SCOTUS 1995, Citizens United v FEC, SCOTUS 2010.

This proposed tentative budget is not ready for public hearing, the Village employee salaries are not even provided. The tentative budget provided is not the tentative budget provided to the board at its October 28th Budget Workshop nor to me via an October 29th FOIL Request that was answered on October 30th.

It was my belief that half of page 9 of the tentative budget answered in my FOIL request was missing, which the new tentative budget justifies that belief.

There are so many questions to be answered concerning this proposed budget that the three-minute rule, which is generally reasonable for meetings and hearings, is not in this case. The lack of information and the numerous items for debate alone substantiate the need for a public workshop open for the public to speak on this partially finished tentative budget.

The budget Calendar for the Village has a deadline of December 20·2024, for the budget officer to prepare the tentative budget, furnish a copy to each member of the board, reproduce copies for public distribution and then file with the Village Clerk (Village Law 5-504).

The Village then has until December 31, 2024, for the village clerk to present the tentative budget to the board and the board reviews and modifies as it sees fit. (Village Law 5-508(1)).

At least five days shall elapse between the first publication and date specified for the hearing, which is to be held not later than January 20, 2025 (Village Law 5-508(3))

The public was just today provided with this new tentative budget and a public hearing cannot be held at this time. Allowing the public just a mere few hours to digest an entire year's budget is unreasonable.
